A Bylaw to Amend the Bylaw to Establish Municipal Grants  
Bylaw # 2025-1

**BE IT ENACTED** by the Town of Alberton as follows:

**PART 1 – APPLICATION AND INTERPRETATION**

1. Title

1.1 This bylaw shall be known and cited as the “Bylaw to Establish Municipal Grants.”

2. Purpose

2.1 The purpose of this bylaw is to amend the Town of Alberton’s Bylaw to Establish Municipal Grants to streamline our financial allocations by removing grants that are no longer active. This ensures that our resources are directed towards current and impactful initiatives.

3. Authority

3.1 This bylaw is made under the authority of the *Municipal Government Act*, RSPEI1988, Cap. M-12.1 as amended from time to time.

4. Definitions

4.1 In this bylaw, any word and term that is defined in the Town of Alberton Bylaw to Establish Municipal Grants has the same meaning as in that bylaw.

**PART II – GENERAL**

5. Schedule “A” - Town of Alberton Grant Programs is hereby amended by the following:

5.1 Schedule A be deleted and replaced with the attached Schedule A which, is updated to remove references to grants that are no longer active.

6. Adoption and approval

6.1 This Bylaw to Amend the Bylaw to Establish Municipal Grants, Bylaw #2025-1 shall be effective on the date of approval and adoption below.





